

Assessment of Controlled Substance Security and Diversion Mitigation



With the societal prevalence of abuse of prescription medications, controlled substance diversion within the hospital setting is a well-recognized risk. Due to the secretive nature of diversion and internal culture of healthcare organizations, diversion activities are often undiscovered and/or underreported.¹ Poorly constructed processes, the high stress level of the healthcare setting and opportunities for activity that is not always supervised all contribute to diversion in the healthcare setting. The results can be devastating:

- Several people at a cancer center developed infections when a diverting hospital worker replaced narcotics with water and injected patients²
- An academic medical center paid a \$4.3M settlement to the Drug Enforcement Administration over diversion³
- A hospital medical technician was sentenced to 39 years in prison after his diversion infected dozens of patients with hepatitis C⁴
