System accreditation leaders face many challenges ensuring CMS compliance across their systems. Resources and budgets are decreasing. There are approximately 128,000 pages of regulations a hospital needs to follow daily across CMS, OSHA, state, Joint Commission, CDC, and others. CMS requirements are complex and constantly changing and it's hard to understand the intent and interpretive guidelines of the regulations and what the CMS surveyors are looking for during a CMS survey. Not to mention that establishing clear accountability across the system is difficult.

Many system accreditation leaders underestimate the likelihood that CMS will visit and find noncompliance. Did you know that sixty calendar days after a Joint Commission survey, a system is at risk for a full CMS validation survey? Survey and certification requests increased \$40 million in 2017 and CMS has increased its budget to conduct 55,600 complaint surveys*. Given the likelihood of a CMS visit, systems need to proactively prepare and respond.
